This contract is subject to the following:

1. A non-refundable Booking and/or Chute Fee of \$500.00 is payable when this contract is signed and returned. This fee is applied to the total breeding fee and the balance of \$ \_\_\_\_\_ will be payable prior to the first shipment of semen.
2. When Triple B Ranch signs and returns one copy of this contract to mare owner, it will be a binding contract to both parties, subject to the terms and conditions in this contract. Breeding season begins February 1st and ends in May in the year of this contract at which time all breeding will be discontinued.
3. This contract is good for one foal only. Multiple foals from the same mare in the same breeding season will require a separate contract and breeding fee for each resulting foal. The only exception to this would be twins that are carried throughout term and foaled by one mare.
4. A copy of the mares registration papers, with current owner listed must accompany the contract.
5. The mare must be in healthy and sound breeding condition. Triple B Ranch recommends the Mare Owner use a veterinarian that is experienced with cooled semen for optimum results.
6. Semen will be collected and shipped on Monday, Wednesday, and Friday only. The stallion will not be taken off this schedule. Semen will be shipped on an "as available" basis in accordance with the fees and requirements listed on the Semen and Stall Reservation Form which must be sent to Stallings Equine Management prior to receiving a shipment of cooled semen or the delivery of a mare to the breeding farm. Mares sent to breeding farm receive preference for semen availability.
7. Live Foal Guarantee. Triple B Ranch guarantees a live foal from the semen contracted on the stallion named in this contract. A live foal is described as a newborn foal that stands and nurses without assistance. If a live foal is not produced or the foal has lethal white syndrome, the mare owner is entitled to a free return service the following year (only) for a chute fee of \$500.00 plus mare care and vet fees. This guarantee is null and void if Triple B Ranch is not notified within one week of the foal's demise or when the mare is found to have aborted. This notice must be accompanied by a statement from a licensed veterinarian. This guarantee is non-transferable without prior consent of Triple B Ranch.

8. Color Guarantee. Triple B Ranch guarantees a foal resulting from this breeding that will meet current APHA regulations for the regular registry. In the event that the foal will not make the regular registry, the Mare Owner will be entitled to a rebreed the following year for a chute fee of \$500.00 plus all semen collection and shipping fees for the cooled semen or the mare care, vet and breeding charges.
9. HYPP Guarantee. Triple B Ranch guarantees that if the mare produces an HH double positive foal with HYPP, the mare owner shall have the option of returning this foal, to Triple B Ranch in return for a free return service the following year (only) for a chute fee of \$500.00 plus applicable shipping fees or mare care and vet fees. The foal must be returned to Triple B Ranch of it's designated representative before the mare owner is entitled to a free breed. The mare owner is entitled to a rebreed. The mare owner agrees that Triple B Ranch and the stallion manager shall be held harmless if the mare produces a foal with any genetic defects.
10. The Mare Owner must administer the necessary Rhino Pneumonitis vaccines at the fifth, seventh and ninth months of pregnancy. Failure to do so results in the nullification of the live foal guarantee.
11. A licensed veterinarian must examine the mare between 18 and 30 days after the last breeding date. Triple B Ranch must be advised of the mare's pregnancy status within ten days of her examination or all guarantees become null and void.
12. A Breeder's Certificate will be issued only after the mare owner has been notified Triple B Ranch that the mare has produces a live colored foal and all bills on the mare have been paid.
13. Should either the stallion or mare die or otherwise become unfit for breeding, Triple B Ranch and the stallion breeding manager are held harmless and this contract shall be null and void. The booking fee and breeding fee may be refunded, applied towards breeding another mare with written approval from Triple B Ranch or transferred to another stallion at the sole discretion of Triple B Ranch.
14. This contract is non-transferable in part or whole without the expressed written consent of Triple B Ranch.

15. A copy of the mare's embryo transfer permit, if applicable, must be sent to Triple B Ranch prior to any shipment of semen or delivery of the mare to the breeding farm.
16. Responsibility for insurance and loss of any kind passes to the mare owner with this contract. Owner assumes the unavoidable risks inherent in all horse-related activities, including but not limited to accident, theft, illness, death, loss, damage and injury to owners horse(s), owner and family members. Owner agrees to look solely to his or her insurance for compensation for any such loss and further agrees to hold harmless Triple B Ranch, the breeding manager, their families, agents and employees.
17. In the event it becomes necessary to refer debts arising from this contract to an attorney for collection, or if a suit is instituted hereon, owner agrees to pay all reasonable court costs and attorney's fees incurred in the suit or collection.
18. Owner further agrees that the contract is made and entered into in Flathead County, Montana and that is shall be interpreted, enforced and transacted under the laws of said state and within the designated county, regardless of the manner of solicitation.
19. Owner's signature on this contract certifies that he/she has read and fully understands all the terms and conditions outlined herein and accepts this contract as a legal and binding instrument on behalf of owner, owner's heirs, successors and assigns.
